## What is this product?

The product is a unit of the fund Nerrick Swiss Equity Fund (the "Fund"), a contractual investment fund of the "other funds for traditional investments" category.

#### Term

The Fund has no maturity date. The Fund could be closed under the conditions set down in the current prospectus of the Fund.

#### **Objectives**

#### **Investment Objective**

The investment objective of the fund is primarily to achieve an attractive riskadjusted performance over the long term and in particular to generate longterm capital growth while spreading risk, mainly by investing directly or indirectly in equity securities and rights such as shares, cooperative shares, participation certificates and profit-participation certificates of companies that are domiciled or predominantly active in Switzerland or Liechtenstein.

#### **Investment Policy**

In order to achieve the investment objective, the fund management company mainly invests the Fund's assets that are not held in liquid assets – namely to the tune of at least 51% – as outlined below, after deduction of cash and cash equivalents: Equity securities and rights of companies that have their registered office or carry out a predominant part of their business operations in Switzerland or Liechtenstein. Up to 49% of these Fund assets may be indirectly invested in target fund units that invest in assets of the above nature.

The Fund may use derivative financial instruments.
